Unfortunately I am unable to attend the webinar tomorrow. As a City we strongly support this sort of planning and we are strong advocates for active transportation, public transportation, electrification, and the necessary transitions to reach a sustainable future.

My comment is this:

We would like to see some provisions or inclusions of using the right of way to implement climate solutions. For example, there are large swaths of our City that are in the Caltrans right of way where we cannot plant trees or install solar panels or implement other climate change strategies. This seems like a missed opportunity and we would like to see more inclusion of this resource (land) being used to implement climate solutions or mitigation strategies.
